#### **ONLINE SEMINARS 2022**

In early 2022, we recognized the challenges faced by TTASSEA in organizing in-person activities due to pandemic-related travel restrictions by hosting an online webinar. We invited Dr. Sittichai Smanchat from Ubon Ratchathani University, Dr. Linda McIntosh from Laos, and Dr. Tjok Ratnacora Sudharsana from the Indonesian Institute of Art, Denpasar. Their research focuses on the significant impact of the pandemic on textile artisans in their respective countries.

The webinar "An Age-Old Art in a New-Age Pandemic," moderated by Dr. Sita Laretna Adisakti from Gajah Mada University on May 20, 2022, delivered critical insights into the current crisis.

The pandemic has unleashed profound disruptions, leading to significant market instability, soaring unemployment, and the collapse of the hospitality and tourism sectors. Artisans, who are essential to the creative manufacturing industry, have seen their businesses come to an abrupt halt. It is imperative that we recognize their plight and take immediate action to support these vulnerable workers.

The positive aspect of the pandemic is that it undeniably sparked creativity among textile artisans and strengthened their family ties. With limited access to store-bought chemical paints, artisans chose to embrace traditional natural dyes, leading to innovative ideas that captured the attention of customers and collaborators. This shift resulted in significant breakthroughs and advancements in their craft. Additionally, remote work became the new standard, fundamentally improving their lifestyles.



The webinar was a success, attracting textile enthusiasts from Indonesia and beyond. Participants were taken aback by the revelation that the pandemic prompted a vital period of introspection and creativity, even with limited resources. Our three speakers made it clear that it is imperative to rethink how we establish sustainable and inclusive working environments for cultural and artistic professionals. These individuals are essential contributors to society on a global scale, and their significance cannot be overlooked.

#### 8th ASEAN Traditional Textile Symposium

On May 5, 2022, the World Health Organization decisively declared the end of the public health outbreak. Immediately following this announcement, preparations commenced for the 8th ASEAN Traditional Textile Symposium, hosted by Malaysia from September 25 to 30, 2022, at the Marriott Hotel in Putrajaya, Kuala Lumpur. The symposium highlighted the theme "Celebrating Textiles: A Journey."

The event was inaugurated by His Majesty Seri Paduka Baginda the Yang Dipertuan Agong and Her Majesty Seri Paduka Baginda the Raja Permaisuri Agong, who serves as the co-founder and chairperson of The Yayasan Tenun Pahang DiRaja. This foundation plays a crucial role in bringing together specialists, researchers, and students in traditional textiles to engage in discussions and exchange ideas. Their efforts are essential in preserving and promoting the production and sustainability of traditional woven fabrics and textiles throughout the region.
